This law firm has been retained to represent Stronghold Engineering, Inc. ("SEI") in connection with the referenced matter.

We have reviewed the contract documents, general and special conditions, plans and specifications, and numerous items of correspondence and communications including our client's notices, claims, reports, schedules, time impact analyses, analytical commentary and explanations, requests for additional time, requests for additional compensation, requests for information and clarification, and voluminous supporting materials regarding these and related topics. We have also evaluated the reports from meetings and telephone calls involving the San Joaquin Regional Rail Commission ("Owner") representatives at various levels. We have also considered the responses offered by Owner, and/or the absence thereof.

Based on our review and analysis, it is apparent that the Owner is in material breach of contract for numerous and varied reasons, including without limitation the Owner's continuing failure to meet one of its most fundamental legal obligations: to review, analyze, and respond to claims, notices, inquiries and requests. Most recently, the Owner refused to address the issues raised in SEI's claims correspondence no. 83 dated August 22, 2024 and SEI's claim correspondence no. 84 dated September 27, 2024 including its detailed schedule analysis. Further copies of both items of correspondence are attached.

The Owner's conduct in this regard violates the applicable provisions of the Contract, the Public Contract, and the Implied Covenant of Good Faith and Fair Dealing, including, without

limitation, Sections 1-13b.7 and 1-13.g.2 of the General Conditions, and Sections 9204 and 20104 et. seq. of the Public Contract Code.

The Owner's refusal to promptly and responsibly address these critical issues represents a direct and ongoing threat to SEI's ability to prosecute the contract work. Please be further advised that if Owner continues to refuse to engage in the agreed process for resolving these long-standing issues, our client will take appropriate legal action, and reserves its right to suspend project work pending direction and resolution of the issues.

The foregoing is without prejudice to all rights, remedies, claims, demands, defenses, entitlements, and causes of action to which SEI is or may be entitled, all of which are reserved.
